2016 COMMUNITY BLOCK DEVELOPMENT GRANT (CDBG) UPDATE

The Planning and Government Services (PGS) Division staff are preparing for the next "Annual Competition" for Community Development Block Grant (CDBG) applications. NEGRC Project Specialist, **Jordan Shoemaker**, and Planner **Theresa Owen** attended the 2016 CDBG Applicants' Workshop December 2nd - 4th in Pine Mountain.

The Georgia CDBG program is divided into four components: Annual Competition, the Immediate Threat and Danger Program (ITAD), the Employment Incentive Program (EIP), and the Redevelopment Fund (RDF). While the Applicants' Workshop addresses each of these programs, it is focused most heavily on the Annual Competition. Applications for the regular round, Annual Competition are due to the Georgia Department of Community Affairs (DCA) on April 1, 2016.

Eligible activities must meet at least one of the three U.S. Department of Housing and Urban Development (HUD) National Objectives:

- Benefitting low and moderate income persons,
- Preventing or eliminating blight,
- Meeting other community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health and welfare of the community, and other financial resources are not available to meet such needs

Examples of eligible activities include:

- Public facilities and improvements such as water and sewer facilities, transportation facilities, parks, homeless shelters, community and senior centers
- Housing rehabilitation, reconstruction, and code enforcement
- Economic development in the form of direct loans to businesses or public infrastructure to support new or expanded businesses

Does your community have a project in need of funding support? A good place to look for eligible activities is your community's comprehensive plan and work program. Comprehensive plans and work programs are posted at georgiaplanning.com under the "Your Plan" tab.

NEGRC can provide assistance with your CDBG application. The PGS Division is eager to identify interested local governments from the region as soon as possible to allow ample time for application development. 2016 CLG GRANTS ANNOUNCED

Applications for the next cycle of Certified Local Government (CLG) grants were recently announced by the the Historic Preservation Division (HPD) of the Department of Natural Resources. Eligible applicants include communities designated as CLGs. There are currently 13 CLGs in the NEGRC region. A CLG is a community that has adopted a historic preservation ordinance, designated a local historic district, and participates in design review by an appointed Historic Preservation Commission.

A range of eligible grant activities exist including historic resource surveys, National Register district nominations, local designation reports, design guidelines, public information brochures, websites, conditions assessment reports or preservation plans for buildings and



sites, and bricks-and-mortar rehabilitation for a specific building or site. Historic sites may include, but are not limited to, cemeteries, parks, gardens, landscapes, and battlefields.

Applications must be postmarked on or before **Feburary 1, 2016**. Grant awards will be announced in April 2016, and projects may begin in in May 2016. Additional information can be found on HPD's website under "Economic Incentives" then "Grants" at **www.gashpo.org**.

NEGRC RECEIVES INNOVATION AWARD

The Northeast Georgia Regional Commission was awarded a 2015 Innovation Award by the National Association of Development Organizations (NADO) for the Braselton Brothers Store Rehabilitation project at the Annual Training Conference held in late October in New Orleans. The NADO Annual Innovation Awards Program has been acknowledging creative approaches to regional community and economic development since 1986.

The Town of Braselton is a historic community listed in the National Register of Historic Places. For most of its history, it has served as a rural, commercial center serving a largely agrarian economy. In 2002, leaders grew concerned with the remaining historic properties, their condition, and their potential reuse. Some of this concern was prompted by the proposed realignment of a state route that ran through the downtown. The need to address the downtown's historic properties led to the development of the Braselton Downtown Revitalization Plan and later creation of the Braselton Urban Redevelopment Agency. One property identified in the Plan was the Braselton Brothers Store complex. It was constructed in 1904 and used historically as a crossroads grocery and mercantile center. It, however, existed in a deteriorated condition and offered limited potential in attracting and accommodating new retail and commercial tenants. To provide for both economic development opportunities and historic preservation, the Town sought to rehabilitate the complex. The NEGRC assisted the Town in three ways: 1) project concept development and strategic planning, 2) grant writing, and 3) project management and administration. The project resulted in



the sensitive rehabilitation of a 29,000 SF historic property that created/retained 45 jobs.

TRAININGS FOR PLANNING & ZONING OFFICIALS OFFERED

The Northeast Georgia Regional Commission (NEGRC) is partnering with UGA's **Carl Vinson Institute of Government** (CVIOG) to host two professional planning workshops: "Planning 101" and "Planning 201." The trainings are intended for appointed Board and Commission members, local government staff, and elected officials involved in planning and zoning functions.

Planning 101 will be provided in March 2016, and Planning 201 will follow in April 2016 (dates & locations announcement forthcoming). The instructor for both trainings is **Chrissy Marlow**, Public Service Assistant with the CVIOG. Registration costs for each workshop are \$155.

These trainings have been provided previously in two other Regional Commission areas. The upcoming March and April sessions give local governments in Northeast Georgia the opportunity to receive these trainings with minimal travel costs. 2016 GEORGIA ACADEMY FOR ECONOMIC DEVELOPMENT CLASSES

Each year, the Georgia Department of Community Affairs (DCA) provides a four-day training to enhance the skills of community

leaders involved in economic-development efforts. Recommended participants can be elected officials, local government staff, and others that seek to improve their communities through economic development.

The trainings are held throughout the state in each of the twelve respective Regional Commission regions. The NEGRC region (Region V) trainings will take place on February 3, March 2, April 6 and May 4, 2016. Classes are held on these days from 8 a.m. to 4:00 p.m. and include class materials, meals and breaks. The cost for tuition is \$225. The trainings are also supported by over 20 statewide organizations with direct involvement from Georgia EMA, Georgia Power, and DCA. Space is limited.

GREENE COUNTY WORKPLACE FUNDAMENTALS PROGRAM GRADUATES 3RD CLASS

The Greene County Workplace Fundamentals course held graduation ceremonies on December 4th for 6 persons who completed the 6 week training program. This program is offered in conjunction with the Northeast Georgia Workforce Development Board (WIOA funds), Athens Technical College, Greene County Board of Commissioners and the Greene County Economic Development Authority.

The instruction was delivered by Athens Technical College instructors Monday – Friday for 8 hours each day for 6 weeks. Students were provided instruction in computer literacy and usage, OSHA 10 certification, Forklift Certification and the basics of manufacturing.
