CLG TRAINING OFFERED IN NORTHEAST GEORGIA

Certified Local Governments (CLGs), or communities that have adopted a historic-preservation ordinance and complete design review, are guided by Historic Preservation Commissions (HPC). The Commission members, appointed by their respective local governments, must have expertise and interest in historic resources. In addition, HPC members are required to complete annual training to remain current with the state's Certified Local Government Program requirements.

Georgia's Historic Preservation Division of the Department of Natural Resources provides 2-3 training events each year. Some of these training events are sponsored and provided by a local government. On **Friday, December 13, 2019 from 9am-4pm**, a HPC training will be hosted by the Unified Government of Athens-Clarke County (ACC) in coordination with HPD. This training is a good opportunity for Northeast Georgia Regional Commission (NEGRC) local governments to include HPC members, elected officials and others to learn more about historic-preservation ordinances and best practices for CLGs.

The training will be held at the ACC Planning Department's Auditorium located at 120 W. Dougherty in Athens. **Reservations are required prior to December 6, 2019** and a \$5 registration fee—due upon arrival. CAMERA READY GUIDEBOOK AVAILABLE

The **Georgia Camera Ready** program connects local communities with the state's Film Office and, more broadly, the motion-picture industry. One of the purposes of Camera Ready is to promote and locate the filming of motion picture and television productions in places in Georgia that meet the film producer's needs. The NEGRC's communities are well-used and offer competitive locations for film and television productions.

All of the NEGRC's counties participate in the Camera Ready program. Each of these communities designates a Camera Ready representative to update film locations and act as a "Liaison" with the State. They also assist during movie-location scouting and actual filming. To help these representatives and new communities interested in Camera Ready stay informed about the program, an updated **Camera Ready Guidebook** is available as a resource. It was recently updated and made available and can be found online here: https://cameraready.georgia.org/film/pdf/ GeorgiaCameraReadyGuidebook.pdf. The guidebook is also a good way for elected and local government officials to learn more about the details and best practices in hosting a film and/or television production in their community.

NEGRC STAFF ASSIST WITH OXFORD'S RETREAT

Last month, the City of Oxford held a day-long "retreat" at "The Center" in Covington with Mayor Roseberry, Oxford Councilmembers and City staff. Several guest speakers were included, providing updates on relevant topics. Mayor Roseberry requested NEGRC assistance in facilitating a

SWOT analysis and planning session during the day. **Burke Walker**, NEGRC Executive Director, and **John Devine**, NEGRC Principle Planner, conducted the sessions.

During the three and a-half hour program, City officials reviewed and updated their annual work program and discussed their community's Strengths, Weaknesses, Opportunities, and Threats (SWOT). Councilmembers participated in two, individual groups that prepared responses and reported back to the full body—with Walker and Devine facilitating the input and recording responses.

USDA "PROSPERITY SUMMIT" SCHEDULED FOR ELBERT COUNTY

The United State Department of Agriculture (USDA) is providing a multi-regional "Prosperity Summit" to be held in Elberton on **November 18, 2019 from 9am-5pm** at the Athens Technical College's Elberton Campus located at 1317 Athens Hwy. USDA is directing this informative session to six NEGRC counties including: **Clarke, Elbert, Greene, Jackson, Madison, and Oglethorpe**. As rural counties, Elbert, Madison, and Oglethorpe will be 'targeted' for USDA's programs. The "Summit" is intended for county leadership, community leaders and organizations, and others interested in access to USDA programs and, specifically, involvement as a "Center of Community Prosperity."

Several topic areas will be considered in the "Summit" including: Economic Development, Innovation & Technology, Workforce, and Quality of Life. Within these are specific components that can be addressed through presentations by experts in their respective subject matter. There is no fee for the training "Summit" but registration is required. PLANNING & GOVERNMENT SERVICES STAFF ATTEND FALL DEPARTMENT OF COMMUNITY AFFAIRS CONFERENCE

NEGRC staff from the Planning & Government Services (PGS) Division attended the DCA Fall Conference in LaGrange on October 15-17th. The three-day conference offered seminars on the 2020 Census, rural broadband, comprehensive planning, tax incentive zones, and other topics within DCA's scope of grant, loan, planning, and community development programs. PGS staff also attended Community Development Block Grant (CDBG) training workshops.

On Wednesday evening of the conference, the State of Georgia awarded over \$57 million dollars in grants to local governments at the DCA Awards Dinner. Seven NEGRC communities received 2019 Designations or Awards: **City of Commerce**, **City of Greensboro**, **City** of Hoschton, Jasper County, City of Jefferson, Oconee County, and Oglethorpe County. LOW INCOME ENERGY ASSISTANCE PROGRAM (LIHEAP)

The Georgia Low Income Energy Assistance Program (LIHEAP) is a federally-funded program that helps low-income households with their home energy bills. The purpose of LIHEAP is to provide appropriate and timely financial assistance to:

- Low-Income eligible households;
- Energy crisis assistance to households experiencing heating or cooling emergencies that are life threatening;
- Provide long-term, low-cost residential weatherization assistance.

Starting November 1, 2019, local Community Action Agencies will begin scheduling appointments for senior citizens (age 65 and older) or those unable to leave their home due to health reasons. The program will open to the general public on December 2, 2019 and last until all funds are exhausted.

This program will pay a one-time payment of up to \$400 to an applicant's primary heating vendor. A person may be eligible for assistance if their household's total income is at or below the following:

Applicants may apply for assistance at your local Community Action Agency, which are:

- 1. Ninth District Opportunity, Inc. serves Barrow, Clarke, Elbert, Jackson, Madison, Oconee and Oglethorpe counties. Appointments can be made by calling (855) 636-3108 or go through internet scheduling at www.ndo.org/eap.
- 2. Overview, Inc. serves Greene, Jasper and Morgan counties. Appointments can be made by calling 478-453-4111.
- 3. Partnership for Community Actions serves Newton and Walton counties. Appointments can be made by calling 404-537-4300.

Applicants must bring the following information with them to their appointment:

- Proof of income for all household members for the past 30 days
- Proof of Social Security number for each person in the household
- · Most recent Gas and Electric Bill for the household



Proof of citizenship or legal immigrant status for each person in household

MEDICARE'S OPEN ENROLLMENT PERIOD

Medicare's Open Enrollment runs **October 15 through December 7**, **2019** and is the time of year when you can make changes to your Medicare coverage. Participants can make as many changes as needed to their Medicare coverage during Medicare's Open Enrollment. The last change will take effect on January 1, 2020. Eligible participants are encouraged to take action to make sure your coverage will meet your needs in 2020. Below are three tips for making changes during open enrollment:

- 1. Know the changes you can make during Medicare's Open Enrollment.
 - The changes you can make include:
 - Joining a new Medicare Advantage Plan or Part D Prescription Drug Plan
 - Switching from Original Medicare to a Medicare Advantage Plan
 - Switching from a Medicare Advantage Plan to Original Medicare (with our without a Part D Plan)
- 2. Review your coverage for 2020
 - Medicare Advantage and Part D plans usually change each year. Make sure that your drugs will still be covered next year and that your providers and pharmacies will still be in the plan's network
- 3. Know who to contact if you have questions.
 - State Health Insurance Assistance Program (SHIP), which in Georgia is called GeorgiaCares. Counselors can help you review your options and pick a plan that meets your needs. Please contact GeorgiaCares at 1-866-55AGING (1-866-552-4464), Option 4.
 - Medicare Advantage Plan/Part D Plan-contact your plan directly about your benefits, coverage or costs. If you do not receive your Annual Notice of Change (ANOC) or Evidence of Coverage (EOC), contact your plan to request changes. You should also talk to your doctor and other medical providers to find out which plans they accept.
 - 1-800-Medicare or www.medicare.gov Calling 1-800-Medicare or visiting www.medicare.gov are ways to find plans in your area or change your coverage during Medicare's Open Enrollment Period. Medicare will send you a new Medicare & You Handbook in the mail each fall containing information specific to your region.

It is important to remember that you should make any necessary changes to your Medicare coverage by December 7, 2019 in order for the changes to take effect January 1, 2020. If, in 2020, you need to change your Medicare coverage, you may have the opportunity to make changes if you are enrolled in a Medicare Advantage Plan or have Extra Help.
