DAS AND NEGRC'S AAA TO HOST STATE SENIOR HUNGER LISTENING SESSIONS

The Department of Human Services' (DHS) Division of Aging Services (DAS) in conjunction with the local Northeast Georgia Senior Hunger Coalitions will host a listening session to gain input from key stakeholders and determine how the State of Georgia will address Senior Hunger in the next Senior Hunger State Plan. The listening session will be virtual and take place on **April 10th at 1:00 p.m.**

To ensure the listening sessions are meaningful and allow stakeholder opportunities to provide valuable feedback, DAS has partnered with Making Ideas Visible, LLC who will host and lead the listening session. Making Ideas Visible, LLC collaboratively designs and facilitate human-centered, immersive experiences that ignite creativity and guides those in attendance to clarity, alignment and cohesion while building a better future together.

NEGRC AND GMRC MEET AT THE FOOD BANK OF NORTHEAST GEORGIA TO DISCUSS POTENTIAL COLLABORATIONS

On February 9, 2023, the Northeast Georgia Regional Commission (NEGRC) met with the Georgia Mountains Regional Commission (GMRC) at the Food Bank of Northeast Georgia's (FBNEG) Athens distribution facility on Newton Bridge Road. The FBNEG serves 14 counties within the two Regional Commission areas and has two operational locations, one in Athens-Clarke County and one in the City of Clayton.

The three organizations discussed the Food Bank's role in both the Regional Commissions' areas, the conditions of food security in their respective counties, potential avenues for multi-regional and multi-state collaboration, and grant funding opportunities for the Food Bank to access. Currently, the FBNEG is underway with an expansion project in Athens-Clarke County to increase their service capacity by 42% and total facility size by 65%. That project is funded by Community Development Block Grant – Coronavirus (CDBG-CV)

funds that were awarded in December 2021 and administered by NEGRC staff. The project is expected to be completed by April 2024.

The NEGRC looks forward to collaborating with GMRC in this multi-regional effort and providing support to non-profits in the twenty-four (24) county areas.

OCONEE COUNTY AND THE CITY OF ELBERTON CLOSEOUT CDBG PROJECTS

NEGRC Planning and Government Services (PGS) staff assisted in closing two Community Development Block Grant (CDBG) projects in early February, including Oconee County and the City of Elberton.

Oconee County received CDBG funding through the regular competitive funding cycle in 2020 for the expansion of their Senior Center. This project added approximately 2,500 square feet to the facility and provided teaching rooms, a large group exercise room, and ADA-accessible bathrooms and showers. This new space will serve the growing senior population in Oconee County for years to come. The NEGRC would like to acknowledge Oconee County staff Merry Howard, Justin Kirouac, and Melissa Braswell for their guidance and assistance throughout the project.

The City of Elberton received CDBG-RDF funding in 2020 for the rehabilitation and stabilization of the historic Bailey Building, located on the downtown square. This building is believed to be the oldest structure on the square, dating back to the 1840's. The Bailey Building had fallen into disrepair and was purchased by the Elberton DDA in 2017. The 6,000 square foot building is being repurposed to include two retail spaces on the ground floor and future apartments on the second floor. The NEGRC would like to acknowledge Elberton staff **Lanier Dunn** and **Cindy Churney** for their assistance throughout the project.

Congratulations to the recent graduates of the Foothills Barrow/WorkSource Northeast Georgia WeldReady course that was held at the Foothills Barrow County Campus. This collaboration was between Foothills Charter Education High School, the Northeast Georgia Regional Commission/ WorkSource Georgia and Workforce Innovators, Inc. The training provided 10 weeks of instruction in welding and related employment preparation. The February 2023 graduates received certification in OSHA 10, Lean Six-Sigma White Belt, First Aid/CPR/ AED, Basic Forklift Operation and American Welding Society (AWS Certification). Funding is provided through Foothills Charter Education High School and WorkSource Northeast Georgia through a U.S. Department of Labor's (DOL) Workforce Opportunity for Rural Communities (WORC)/ Appalachian Regional Commission (ARC) grant and a United Way of Northeast Georgia grant. Barrow County is one of four ARC counties in the NEGRC. For information on this
