## UGA TO HOST LOCAL WETLANDS PROTECTION WORKSHOP IN ATHENS

Save the date for **May 7**, **2024** for a Local Wetlands Protection Workshop co-hosted by the UGA River Basin Center and UGA School of Law Land Conservation Clinic. It will take place at the Delta Innovation Hub at the University of Georgia. The workshop will cover:

- · Background on wetlands and the federal wetlands regulatory system,
- How the legal landscape is evolving after the US Supreme Court Sackett Decision, which sharply reduced federal wetlands protection and
- Options for local government wetlands protection, including model ordinances and conservation programs.

**Registration will open in March at https://rivercenter.uga.edu/local-wetlands-protection-workshop/**. NEGRC's Planning and Government Services Division (PGS) is helping with the event and will share registration information with our member local governments when it becomes available.

### NEGRC REGIONAL TRANSIT DEVELOPMENT PLAN CONTINUES WITH INPUT OPPORTUNITIES

The Northeast Georgia Regional Commission (NEGRC), in coordination with the Georgia Department of Transportation, is creating a Regional Transit Development Plan (TDP). The Regional TDP process explores regional transit needs and opportunities, defines a long-range vision and goals for the future of the 12-county transit system in the region, and identifies implementable transit projects to advance the vision and goals.

NEGRC hosted a second virtual public meeting in the Regional TDP process on February 27th and has an online survey available for the public until March 31st. Public feedback will be essential to inform future transit system investments in our region.

## GEORGIA CRISIS AND ACCESS LINE PRESENTATION TO SENIOR CENTER DIRECTORS AND AGING STAFF

From 2019-2020, Georgia ranked 31st in suicide deaths in the United States. During the COVID-19 pandemic, from April 2020 to April 2021, Georgia saw a 36% increase in overdose deaths.

On February 9, 2024, **Wendell Fields**, Community Liaison for Behavior Health Link, presented on the Georgia Crisis and Access Line (GCAL), which is a statewide resource available to those considering suicide or experiencing a mental-health crisis. Mr. Fields reminded the group that mental illness does not discriminate and can happen to anyone regardless of race or socioeconomic status. Mr. Fields challenged the group to bring awareness to mental health and help reduce the stigma associated with mental health.

GCAL is available to anyone in Georgia 24 hours, seven days a week, 365 days a year. Individuals can contact GCAL via phone, chat, and text to receive person-centered interventions. GCAL can connect the individual in crisis with necessary interventions such as community resources for follow-up, mental health inpatient facilities for voluntary admission, or dispatch of the mobile crisis unit, which is trained staff that will go to the individual experiencing a crisis for



further assessment which may lead to an involuntary admission to a mental health inpatient facility.

In July 2022, 9-8-8 was launched so that there would be a dedicated line for those considering suicide or experiencing a mental health crisis. 9-8-8 is an immediate connection to a trained, mental-health professional and diverts calls from 911.
