NEWTON COUNTY BOARD OF COMMISSIONERS HOLDS ANNUAL RETREAT

The Newton County Board of Commissioners held its annual retreat on October 7th at the Fire Services Headquarters in Covington. The day-long event kicked off with a financial update presented by Wayne Tamplin and Pat Malcom of Treadwell, Tamplin and Company. This was followed by a water resources presentation led by Water Resources Director James Brown. County Attorney Tommy Craig provided an overview of the Bear Creek Reservoir effort. Jenny Craig of the County Attorney's Office presented information concerning the next SPLOST referendum. It was determined that a target date for such is May 24, 2016. The afternoon portion of the session was devoted to two topics - form of government and solid waste. Ronnie Cowan, Chairman of the Form of Government Committee, and Solid Waste Committee Chairman Wayne Haynie were present for discussion regarding these items. It was agreed that BOC efforts pertaining to these topics will continue in the immediate future. Executive Director Jim Dove and Executive Assistant Mott Beck facilitated the retreat, and a summary has already been made available to Chairman Keith Ellis and County Clerk Jackie Smith for dissemination.

NADO ANNUAL TRAINING CONFERENCE

Jim Dove attended the Annual Training Conference of the National Association of Development Organizations (NADO) held October 25th – 28th in New Orleans. He was among more than 600 attendees representing over 200 organizations throughout the United States. The conference agenda was filled with numerous interesting and informative sessions including concurrent learning labs, regional membership meetings, and plenary sessions. Dove participated in a panel discussion on "Regional Development Organization's Role in Cultivating Healthy Communities". A highlight of the conference was the keynote luncheon featuring the Honorable Jay Williams, Assistant Secretary of Commerce for Economic Development, U.S. Economic Development Administration. The conference also highlighted Innovation Award winners for 2015. The Northeast Georgia Regional Commission was the recipient of such an award for the Braselton Brothers Store Rehabilitation.

CENTENNIAL FARMS AWARDED

On October 9th, two Northeast Georgia farms were awarded Centennial Farm status at the Georgia National Fair in Perry. Boyd McLocklin Farm in Barrow County and Hickory Hill Farm in Oglethorpe County received the honor. There are 482 recognized farms across the state, and 40 are located in Northeast Georgia. The program was developed in 1993 to compliment family farms that preserve Georgia's agricultural history by maintaining working farms for over 100 years. The awards are made by the Georgia Historic Preservation Division in conjunction with the Georgia Farm Bureau Federation, Georgia Department of Agriculture, Georgia Forestry Commission, and the Georgia National Fairgrounds and Agricenter. NOMINATIONS OPEN FOR REGIONAL RESOURCE PLAN

The NEGRC's Planning & Government Services (PGS) Division will be updating the Regional Resource Plan, developed in 2010. As required by the Department of Community Affairs, this document identifies important natural and cultural resources throughout the twelve-county region and offers guidance for the protection and management of these resources. In addition, the plan is taken into consideration when determining and planning for the impacts of new developments.

The NEGRC is seeking nominations of important regional resources to be considered for incorporation in the updated Regional Resource Plan. Individuals, interested organizations, local governments, and governmental agencies are eligible to nominate resources, which will then be considered by the PGS Committee for inclusion in the plan. Nominations will be accepted December 1, 2015 through January 31, 2016.

GRANTS RECEIVED BY GEORGIA DEPARTMENT OF ECONOMIC DEVELOPMENT WORKFORCE DIVISION

The US Department of Labor recently announced that the Georgia Department of Economic Development, Workforce Division, was awarded two grants which will provide a direct impact to the Northeast Georgia region.

The first grant was an Apprenticeship Grant for \$2.9 million which will expand entry-level advanced manufacturing apprenticeships, create new apprenticeship programs in industrial maintenance and mechatronics to upgrade the skills of incumbent workers, and develop and implement strategies to attract workers to Georgia's advanced manufacturing workforce. This will be delivered through collaboration

between technical colleges and employers, some of which are a part of the Northeast Georgia service area.

The second grant received was to serve persons with significant disabilities, ages 14 and older. This \$2.4 million grant will provide funds to two local areas, Northeast Georgia and Augusta, to employ a Disability Resource Coordinator. This grant will provide customized career pathways in high-demand industries to expand the services and resources available to persons with disabilities through the one stop career centers in Georgia. It is estimated that approximately 215 persons will be served over the three year grant period. The purpose of the grant is to increase the number of persons with disabilities who are employed.
