BOGART OPENS NEW FACILITY

The City of Bogart celebrated the opening of its "Historical and Agriculture Center" on August 4th during an evening event. The historic building was originally constructed as a vocational agriculture building with classrooms, a cannery, and meeting space. It was rehabilitated by the City in 2014 for Council chambers, a historical museum, and event space. The project received a 2015 Georgia Trust for Historic Preservation award for "Excellence in Rehabilitation."

The dedication event was attended by elected officials, residents, and members of the larger community. After a ribbon cutting ceremony, presentations were provided by several councilmembers, Representative **Regina Quick** (District 117), and the project Architect, **Hank Houser** of Houser Walker Architecture. After the presentations, attendees toured the museum and its gift shop and enjoyed cake and punch to the music of a live band in the building's event space. The facility is available to rent for special events and gatherings. A newly landscaped garden area is also available. NEGRC PROVIDES ECONOMIC DEVELOPMENT WORKSHOP

CITY OF MADISON RECEIVES FUNDING APPROVAL

In July, the City of Madison received notification of a \$100,912 award from the Georgia Department of Community Affairs (DCA) Redevelopment Fund Program (RDF). The City, through the Downtown Development Authority of Madison (DDA), will use these funds to remove slum and blight in the Canaan Historic Neighborhood within the City of Madison. The RDF funds will be used in conjunction with funds allocated by the City of Madison for acquisition and grant administration, as well as an approximately \$22,427 contribution from the DDA and \$46,345 in private investment. These funds will finance the construction of a new commercial building following the demolition of a blighted commercial structure located at the corner of Fifth and Burney Streets. The DDA will lease the new facility for use as a corner pantry store providing basic goods and groceries to the local community. The primary goals of the project are to eliminate blight on an area basis and support the creation of two full-time permanent jobs, both of which will be provided for low- to moderate-income individuals.

The Redevelopment Fund program is extremely useful for projects that require improvements in traditional downtown areas and particularly single or detached commercial buildings that have multiple spaces. Madison is the fifth successfully awarded RDF developed by PGS staff. PGS staff is able to assist local governments with numerous downtown efforts including: development of Urban Redevelopment Plans (URPs), concept development of projects identified in the URP, and application preparation for potential projects. Communities without Downtown Development Authorities or other formally established organizations may also wish to consult PGS staff on their potential formation.


JEFFERSON UPDATES DESIGN GUIDELINES

The NEGRC's Planning & Government Services (PGS) staff recently had the opportunity to assist the City of Jefferson in updating its design guidelines. Design guidelines are used as an educational and planning tool in making appropriate exterior changes to properties located in designated historic districts. They also provide historic preservation commissions with a document on which to base their evaluation of proposed changes to properties within locally designated historic districts.

One of the project's objectives was to create design guidelines that were easily understood through the use of simple text and photographs. The photographs included in the final document, for example, were taken exclusively in Jefferson of existing historic properties. Another unique aspect of the design guidelines is the inclusion of two historic cemeteries, Woodbine and Paradise A.M.E.

The project, overall, was made possible by funding provided by both the City of Jefferson and the NEGRC's planning contract from the Georgia Department of Community Affairs (DCA). Some design guidelines use text and graphics that are unoriginal; creating an unfamiliar document. The approach to the Jefferson project was to customize the content based on community input. PGS staff worked closely with Beth Laughinghouse, Jefferson Main Street Manager, in developing the design guidelines.

PLAN IMPLEMENTATION MEETINGS SCHEDULED

The Planning & Government Services (PGS) Division staff have initiated work on FY16's Plan Implementation Meetings (PIM) for Athens-Clarke County, Barrow County, Morgan County, Newton County, Oconee County, and Walton County (and the municipalities therein).

The NEGRC must meet with each local government in the region once every two years, and elected leadership and key staff involved in implementing the comprehensive plan must attend. NEGRC recommends holding one meeting per county, with all local governments participating, to facilitate coordination and collaboration opportunities. Content includes discussion on use and implementation of the comprehensive plan, with a focus on how the Regional Commission can assist the local government with specific plan activities; PGS staff also review key components of the regional plan and regional resource plan.

In August 2015, Mr. Walker sent PIM-related letters to all chief elected officials within the counties listed above, and PGS staff will work with communities to schedule the meetings at an appropriate time for the local governments.
