#### **BRINSON TO RETIRE; PAGE NAMED COMPTROLLER**

NEGRC Comptroller Evans Brinson recently announced his retirement, effective January 31st, and will be succeeded by Alicia Page. Mr. Brinson joined the organization in a staff accounting role in October 1990, and was promoted to his current position in March 1992. He has worked closely with the Commission's Audit and Finance Committee and senior staff in preparation and management of the

organization's annual budget. In addition, he has provided accounting assistance to the Upper Oconee Basin Water Authority since its inception. In recent years, he has directed the NEGRC Coordinated Transportation Program. Executive Director Jim **Dove** stated, "Evans has been instrumental to the overall success of this Commission for nearly 27 years...every audit during his tenure is a reflection of his outstanding service."

Ms. Page was selected to fill the Comptroller position and joined the Commission staff on November 1st. She was employed by the City of Gainesville from 2009-2016, and most recently served as Interim Chief Finance Officer and Administrative Services Officer. She graduated Brenau University with a Bachelor's in Business Administration. A Level I and II Certified Local Government Finance Officer, she served recently as President of the Georgia Government Finance Officers' Association. Dove indicated, "We are very fortunate that our search resulted in the hiring of Alicia for this position. Her talents and expertise should serve us well."

## PLAN FIRST APPLICATION DEADLINE APPROACHING

The Georgia Department of Community Affairs (DCA) annual May 15<sup>th</sup> deadline to apply for "PlanFirst" designation for your community is fast approaching. The program, now entering its fourth year, recognizes communities that have proven a commitment to planning through a demonstrated track record of implementing their Comprehensive Plan's work items, as well as a history of good plan development.

Being designated as a "PlanFirst" community allows access to incentives such as an increased level of visibility, eligibility for funding, and reduced interest rates on certain DCA and Georgia Environmental Finance Authority (GEFA) programs. It also provides eligibility for PlanFirst communities to apply for Community Development Block Grant (CDBG) funding each year, rather than every other year following an award.

Four communities within our region have been designated "PlanFirst" communities in the first two years of the program. They include: Athens-Clarke County, Braselton, Madison, and Porterdale. Once awarded, the designation lasts for three years. Communities interested in receiving or renewing their "Plan First" status are encouraged to apply, or reapply. The NEGRC's Planning and Government Services staff are available to offer guidance to interested communities as they navigate the application process.

#### **BE THERE 4 SENIORS RALLY**

Georgia seniors will gather at the south wing of the State Capitol on January 19<sup>th</sup> at 11:00 a.m. to call on legislators to support budget requests that would remove seniors on the waiting list for aging services.

Hundreds of older adults and supporters are expected to attend the rally, Be There 4 Seniors, to advocate for \$10 million in additional state funding for home and community based services in FY 2018. These programs can delay nursing home placement for 50 months, on average, at a fraction of the cost.

The End the Wait Campaign involves a request for increased funding for services that help older adults remain in their homes and in their communities for as long as possible. The new funding would help reduce long waiting lists for essential services such as home delivered meals, caregiver support and transportation. These programs help promote independence, support caregivers, and protect the vulnerable.

### 2017 CDBG APPLICATION CYCLE UNDERWAY

In December 2016, the Georgia Department of Community Affairs (DCA) presented a three-day "Applicants Workshop" in Macon to kick off the 2017 Community Development Block Grant (CDBG) cycle. Applications can seek financial assistance for a range of activities to benefit low-to-moderate income persons. Examples of activities include water and sewer infrastructure, senior centers, Boys & Girls Clubs, and head-start facilities.

One possible addition to this year's application cycle is an increase in potential award amounts. Previously, grant awards were capped at \$500,000 but that limit may increase to \$750,000 (pending final approval, expected in January 2017). In Northeast Georgia, applications compete against other projects statewide; resulting in a very competitive review environment. Local governments are eligible applicants and are strongly encouraged to begin early to allow time to fully complete grant applications. Several local governments from Northeast Georgia attended the December workshop as well as four members of the NEGRC's Planning and Government Services Division.
